


This thermoelectric mini fridge is specially designed for your skincare and cosmetic products, beauty tools, and essentials.

How to get started

- 1.Plug in Mini Fridge [SEP]
- 1.1Plug your Fridge into an outlet using the included power adapter. The unit is on. The LED indicator will light up. [F]
- 1.2The unit requires a one-hour minimum to reach its ideal skincare and beauty product storage temperature. More time will be taken if more storage is inside.
- 1.3 You can adjust the intensity of the LED light on the door. Three levels of brightness can be adjusted.

Security Precautions
